In witness whereof, the authorized representatives of both parties have **signed this Memorandum of Understanding**, thereby placing on record their agreement and commitment to the matters stated above.


Academic Collaboration and Support


Both parties shall mutually agree to provide academic support and collaborate in the following areas:

2. Joint proposal, organization, and implementation of **research and training programmes** aligned with national priorities and sponsored by recognized funding agencies, with opportunities for faculty members from both institutions to participate.
3. Exchange of **research-related information and expertise**, subject to prior approval from the competent authorities of the respective institutions.
4. Support for student development programmes by providing opportunities for practical exposure, guidance, and mentorship, based on willingness and institutional capacity.
5. Joint organization of **short-term continuing education programmes, workshops, seminars, or conferences** on topics of mutual academic and research interest, with participation from faculty members of both parties.
6. Shared access to **library facilities**, where feasible, and promotion of academic interaction through **guest lectures**, expert talks, and academic engagements addressing research, innovation, and societal needs at both institutions.

Terms and Conditions

1. There shall be **no financial obligation** between the parties under this Memorandum of Understanding. Any financial commitments, if required for specific activities, shall be **mutually discussed, agreed upon, and finalized in writing** at the time of execution of such activities.
2. For visits undertaken for the purpose of **advisory services, consultancy, or academic collaboration**, all travel, accommodation, and incidental expenses shall be borne by the **respective institution** of the participating individual concerned, unless otherwise mutually agreed upon in writing.
3. Each institution shall be responsible for obtaining all **necessary internal approvals, consents, permissions, and licenses** of any nature required for the implementation of activities under this MoU, in accordance with their respective institutional policies and regulations.


Intellectual Property



For the purposes of this MoU, "Intellectual Property" shall include, but not be limited to, all "know-how", inventions, discoveries, patents, copyrights, trademarks, designs, trade secrets, and any other proprietary or intellectual property rights, whether registered or unregistered, belonging to either Party. Each Party shall retain full ownership of its respective intellectual property.

Validity and Term

This MoU shall be valid for a period of **three (3) years**, commencing on **5 March 2026** and expiring on **6 March 2029**, unless terminated earlier in accordance with this MoU. Upon expiry, this MoU may be **renewed on annually basis** by mutual written consent of both Parties.
